The following motion was made by Jacob W. Crookston, seconded by Sherwood W. Mate that Highway Superintendent James DeBrine be empowered to negotiate the purchase of a Ford truck, motor grader and V-snow plow, carried.

Sherwood W. Mate moved the adoption of the following motion, seconded by Hart B. Pierce, Jr.: Resolved that the Town Board enter a protest with the NY Central Railroad Company concerning the accident on Saturday, March 13, 1948, in which two people were killed and a third injured at Gooney's Crossing of the NY Central Railroad, located about two miles north of the Village of Palmyra. The Town Board recommends the extension of the signal distance at the present time in force on the railroad crossing, wherein the present distance from the start of the signaling point is only 3500 feet or an elapse of thirty to thirty-five seconds for a fast train to arrive at the crossing and giving the driver of an automobile a short time to clear the crossing. The condition of the crossing being so rough and bumpy, the driver of the automobile proceeds at a very slow rate of speed. Upon vote of the Town Board, the resolution was unanimously carried. A copy of the above resolution was ordered sent to the Syracuse Division, Supervisor of Maintenance and to O. R. Judson of the Claim Department of Rochester, NY, File #700.

Resolution by Sherwood W. Mate, Town Councilman: Whereas it is the intention of the Palmyra, NY, Town Board to establish a Community Center. Whereas the Palmyra, NY, Town Board is about to submit an application for such a project to the NY Youth Commission for its approval; and if approved, to apply subsequently to NYS for partial reimbursement of funds expended on said project as provided by Chapter 556 of the Laws of 1945 as amended.

Now therefore be it resolved that such application is in all respects approved, and Supervisor Sanford M. Young is hereby directed and authorized to duly execute and to present said application to the NYS Youth Commission for its approval.

A petition in the above matter for the creation of a water district having been duly presented to this Town Board, together with the necessary map and plan attached thereto; and an order having been duly adopted by this Town Board on August 4<sup>th</sup>, 1948, for a public hearing of all persons interested the matter on August 25<sup>th</sup>, 1948, at 8 o'clock p.m. (EDST) at the Justice Court Room in the Village Hall on East Main Street in the Village and Town of Palmyra.
