### **Highway Committee - James Welch, Chairman**

1. <u>January Highway Department Report:</u> Mike Boesel submitted his report through January 28:

Highway Superintendent Report For Town Board Meeting 01/28/2010

Since the 12/29/09 meeting we have completed the following work:

- Tree Work Cole Road
- Hauling Sand approximately 500 tons
- Plowing/Sanding –To date this season we have made a total of 51 trips out of the barn. In January 2008 we had made 49 trips and January 2009 we had 78 trips.

Other miscellaneous items include:

- Salt Orders To date this winter season we have ordered 1500 tons of our 3500 ton allotment.
- NYSERDA Energy Audit I am still gathering information to submit for an energy audit for the Town Hall Facility and Highway Facility. I should be making this submission next week.
- JANUARY HIGHWAY DEPARTMENT REPORT
- Street Lights On 12/24/09 I faxed a 'Street Light Outage Report' to NYSEG for 10 lights in the Town and Village. On 1/11/10 I submitted a second report for 14 more lights between the Town and Village.
- Equipment We had our share of equipment repairs during the first two weeks of 2010; T22-alternator, T18 blown hyd filter, T28 frozen air drier, T24 wing cable/arms, T16 blown brake line, T15 blown hyd hose, T16 worn-out plow controller, T12/T17 sander bearings, all misc light repairs. I am still in the process of evaluating the plow controller for T16.
- Equipment Servicing During the last two weeks of this month we have started to service all other pieces of equipment including, E55 Elgin sweeper, E71 sewer flusher, E88 Bobcat, E75 leaf sucker, E60 roller, pickups C1, C2, C4.

- Dog Kennel Plumbing We recently had to make internal plumbing repairs for the water spigot near the dog kennel to function properly. The dog kennel was inspected last week.
- Fuel Facility The fuel island was down again on 1/12/10. The fuel reader and power supply were replaced the next day. Jim Carlett and Ralph Brongo from Pal-Mac CSD and I have been meeting to discuss the replacement of the current fuel management system and system software.

JANUARY HIGHWAY DEPARTMENT REPORT

- Painting Projects We started two painting projects this past week, the highway office and the Bookkeeper/Supervisor offices.
- Treework As time and weather permits throughout the winter we will be performing some treework on our roads and some continued brush mowing. We performed some tree work on Cole Road last week.
- Canandaigua Street Project On January 18, 2010, the Village Board awarded the project to Rizzo Construction. I will keep you posted regarding the project start date, the pre-construction meeting date and the traffic detour.
- CHIPs Funding The Governor's Budget is out and upon review our CHIPs funding is still at the same level as last year. This funding is critical to keeping our roads in good condition.

- 2. <u>Expression of Thanks:</u> Supervisor Miller asked Highway Superintendent Boesel to thank the Highway crew for taking away the satellite dish in the back yard at Town Hall.
- 3. <u>Emergency Equipment Purchase:</u> Councilman Jim Welch filled Board members in on the background of the 1999 Ford controller for a snowplow that no longer works. Mike Boesel obtained several quotes for a new plow plus the controllers.

EMERGENCY PURCHASE OF PLOW & CONTROLLERS

It was determined that a dealer in Syracuse and a dealer in Macedon both carry the plow and parts. Both dealers have the items in stock. The Syracuse dealer's quote was for \$3,886. The Macedon dealer's quote was for \$3,995. Discussion brought out pros and cons for each. In the end, it was decided to go with the Macedon dealer—John

Bodak—as they prefer to deal locally and not have to make several trips to Syracuse to purchase and mount plow. It was also decided to put the old plow in the Spring municipal auction.

The following resolution was offered to Board members authorizing the Highway Department to purchase the snowplow:

## EMERGENCY PURCHASE OF PLOW FOR HIGHWAY DEPARTMENT

WHEREAS, the Town Highway Superintendent has reported that one of the snow plows on a Town truck snowplowing route has broken and replacement parts have been out of production for many years and the Town is unable to utilize this truck for plowing roads on this route, and

WHEREAS, this was an unforeseen emergency, and

WHEREAS, the Town needs to be able to plow, sand and salt the roads on the route for the safety and welfare of the residents who are forced to travel over those roads and the school buses that use those roads, and,

WHEREAS, the Highway Department can ill afford to operate in the snow season without the equipment necessary to make the route safe, and

WHEREAS, if the Town were to bid the purchase of a replacement snow plow, it would mean that the Town would be unable to care for the safety of the people on the snowplowing route until sometime in early March or later, and

WHEREAS, there are no other snow plows available to be used by the Town, and

WHEREAS, due to the amount of the snowfall that is falling this year and the amount of snowfall predicted, the Town must take immediate action to replace the snow plow, and

WHEREAS, there is no availability to wait;

**NOW, THEREFORE, BE IT RESOLVED,** that the Town Board does hereby declare an emergency situation in the Highway Department, and

**BE IT FURTHER RESOLVED,** by virtue of the possible danger to the safety and the well-being of the people of the Town of Palmyra, the bidding process for a new snow plow is out of the question, and

BE IT FURTHER RESOLVED, that the Highway Superintendent shall solicit quotes as to the price and delivery from suppliers of snow plows, and shall select the snow plow that most nearly compliments the existing snow plows as to size, operation and handling used by the Town, which is available for the lowest price, and

**BE IT FURTHER RESOLVED,** that the Highway Superintendent is not authorized to expend more than \$4,500.00 to replace the snow plow, and

BE IT FURTHER RESOLVED, that the Town Board shall approve a purchase offer for a sander for the Highway Superintendent based on the Highway Superintendent's report on the costs and delivery which he has obtained, and the reason he selected the provider and the snow plow in the purchase order.

Instead of the phrase "BE IT FURTHER RESOLVED, that the Highway Superintendent is not authorized to expend more than \$4,500 to replace the snow plow..." Nussbaumer proposed the number be changed to a maximum of \$4,000.

Second: Jim Welch Vote: 4 Ayes. Carried. Councilman Michael Lambrix voted nay, saying that the \$4,000 should be subtracted from the Highway budget.
