Fifteen dollars per mile for 80 miles of highway in town for the general primary work.

\$300 for grading and graveling Maple Avenue 1½ miles from West Shore Railroad north to New York Central Railroad.

\$1000 for the repair and construction of sluices, culverts, and bridges having a span of less than five feet.

\$600 for grading and graveling road leading from Brown's Corners west to town line, a distance of ½ mile.

\$800 for grading and graveling Walker Road northwest from NY Central Station to Durfee's Corners.

\$300 for grading and graveling road leading from Jeffery's Corners to the Rodney Parker farm.

\$800 on the road commencing at Charles Eldridge's to town line 11/4 miles

There shall also be kept in hands of the Supervisor the sum of \$2072.07 for a Reserve Fund.

A bill in the sum of \$18.30 was received from Martha L. Lytle as administratrix for the estate of James P. Lytle, Constable, for service rendered to the Town from date of last audditing day to time of his death. Upon motion, duly carried, the Clerk was instructed to draw an order for the amount.

Knapp, who was elected in November last. The Clerk was instructed to notify Mr. Durfee of his appointment and to file the appointment in the records of the Town.

Superintendent Hedden reported that the proposition of covering the flooring of the highway bridge over the creek on Railroad Avenue with concrete was found to be impossible, and that he would make arrangements to have it planked according to the agreement existing between the Town and the New York Central Railroad Company.

Regular meeting of the Plamyra Town Board was held at the Town clerk's Office on Friday, June 14, 1912. Present: C. F. Griswold, T. L. cook, J. L. Warner, and H. L. Averill. Meeting was called to ordeer by Mr. Griswold, and minutes of the last meeting were read and approved.

Superintendeent of Highways, C. H. Hedden was present and told of work now being done on the highways of the town.

Overseer of the Poor, A. C. Hopikins, appeared before the Board and reported cases relative to the Poor Fund.

Clerk reported that Fred H. Durfee, who was appointed Justice of the Peace in place of Spencer L. Knapp on april 19, and who had been officially notified of said appointment had declined to serve.

Regular meeting of the Town board was held at the Office of the Town clerk on Friday, August 16, 1912. Present: C. F. Griswold, Supervisor; T. L. Cook and C. W. Williamson, Justices; H. L. Averill, Clerk; and C. H. Hedden, Superintendent of Highways. Meeting was called to order by Mr. Griswold, and minutes of the last meeting were read and approved.

On motion of Mr. Williamson, a resolution was passed authorizing the Town Clerk to furnish a bond of \$500 to be approved by the Board in accordance with the new law requiring all town clerks to furnish bonds.

On motion of Mr. Averill, duly carried, Mr. Williamson was authorized to purchase a filing cabinet for justice blanks, papers, etc. from the Williamson Law Book Company for the use of the town justices.

Mr. Hedden, Town Superintendent of Highways, was present at the meeting and states that the road work throughout the town was progressing finally and that the lumber had been ordered for the planking of the highway bridge on Railroad Avenue over Mud Creek and that same would be done as soon as the material arrived. Half of the expense of such labor and material is to be paid by the New York Central Railroad Company.

Special meeting of the Town Board was held on Tuesday, September 3, 1912, for the purpose of designating polling places and for the transaction of any other business that was necessary. Present: C. As the Commissioners recommended the laying aside of the machines for the year, and as most of the other towns in the county were going to accept the Commissioners' recommendations, he had notified the Town Clerk to inform the Commissioners that Palmyra would vote by ballot at the General Election held on November 5, 1912.

A resolution was passed authorizing the Town Clerk to provide a sufficient number of voting booths and ballot boxes to comply with the law, to be used at the General Election on November 5, 1912.

Annual Town Settlement Day for the Town of Palmyra held at the Town Clerk's Office on Saturday, December 28, 1912. Present: C. F. Griswold, Supervisor; C. W. Williamson, T. L. Cook, and J. L. Warner, Justices; and H. L. Averill, Clerk. The meeting was called to order by Mr. Griswold, and minutes of the previous meeting were read for information.

The accounts of Overseer of the Poor, A. C. Hopkins, were examined and audited; and with his annual report were accepted and ordered placed on file. The report showed expenditures of \$846.69 for the year 1912; receipts amounting to \$896.67, and a balance on hand as of December 31, 1912, of \$49.98.

The records and accounts of the Supervisor in all departments of his office were examined and found to be correct; and the books were signed by the members of the Board.

The report of the Soldiers' Relief and Memorial Day Fund showed receipts for the year amounting to \$134.70 with expenditures amounting to \$73.30, leaving a balance in the fund on December 31, 1912, of \$61.40. On motion, duly carried, the report was accepted and order placed on file.

On motion duly carried, the following resolution was carried: Resolved, that the Supervisor be authorized to pay to the County Treasurer from the General Fund of the town the sum of \$1453.06, the same being the amount charged to the Town of Palmyra as the town's share for the construction of county highways on Canandaigua Street during the year 1912.

On motion, duly carried, the following resolution was offered and adopted: Resolved that beginning with January 1, 1913, the salary of the Town Clerk shall be fixed at \$400 annually in lieu of all fees coming into that office, which fees shall be paid over to the Supervisor.

On motion, duly carried, the following resolution was offered and adopted: Resolved that the Supervisor be authorized to pay all bills on the Miscellaneous Account presented to him by the Town Superintendent of Highways.

On motion, duly carried, the following resolution was offered and adopted: Resolved that the compensation of the Supervisor and Town Clerk under the Highway Law be fixed at the same rate as last year--\$125 annually for the Supervisor, and \$50 annually for the Town Clerk.

On motion, duly carried, the following resolution was adopted: Whereas, the Town Board of the Town of Palmyra has been informed that the County Treasurer of the County of Wayne has paid the sum of \$1453.06, being fifteen per cent of the amount claimed to be due by this town for the construction of county highways in this town for the year 1912, and

Whereas by Chapter 83 of the Laws of 1912, towns were exempted from the payment of any amount by reason of the construction of County Highways,

Now therefore be resolved that the Supervisor of this town be and hereby is authorized to file with the Court of Claims and with the Attorney General notice of intention to present a claim as against the State of New York for the recovery back of the amount so paid for the construction of county highways in this town for the year 1912,

And be it further resolved that the Supervisor of this town be and hereby is authorized to take any further steps in the employment of counsel or in the signing of pleadings or notices as may be necessary to carry through to completion the prosecution of such claim as against the state.
