Supervisor Miller waved the reciting of the pledge of allegiance.

Upon roll call, the following Board members were present: Kenneth Miller, Supervisor James Welch, Deputy Supervisor Todd Pipitone, Councilman Brad Cook, Councilman

#### **ATTENDENCE**

Also in attendance were Book Keeper Petra Anderson and Highway Superintendent Mike Boesel.

#### **AGENDA**

Mr. Boesel submitted the following explanation as to why it would be necessary for the book keeper to immediately pay Beam Mack for a 2021 Mack Truck:

**Meeting Purpose:** Authorize immediate payment for 2021 Mack Truck (T18) <u>using current CHIPs funding</u> so that I can submit for reimbursement <u>this week.</u>

#### Current 5130.2 (Equip Acct):

In 2020, we budgeted \$284K to replace T18 (1999 Single-axle Mack) and 2 Bobcat items.

The Truck was ordered in late 2019, but due to COVID, the new truck has not been outfitted yet and I expect delivery in January 2021.

We also purchased a new Kubota Lawn mower in 2020 and used some unplanned funding from our 5130.2 Equip Acct.

Thus, our current unexpended 5130.2 Equip Acct is \$179K instead of \$190K.

#### **Current CHIPs Situation:**

Due to COVID and state budget woes, the Gov and NYS have been warning about potential cuts in funding from various programs, including CHIPs, up to 20%.

Thus, the sooner we spend our CHIPs funding the better chance we have of not losing it.

We currently have \$263K in CHIPs funding available for our use. (\$264 - \$190 for truck = \$73 remaining for road work)

The deadline to submit for this  $2^{nd}$  Round of CHIPs Reimbursement was extended from 8/26 to this Friday, 9/4. The  $3^{rd}$  submission Round deadline is 11/12/20

I understand municipalities who submitted for CHIPs reimbursement in the 1<sup>st</sup> Round (deadline was back in June) received 100% of their CHIPs funding submissions.

But I'm being told that this  $2^{nd}$  Round <u>could be</u> small across the board cuts and that if the NYS Budget woes continue, then the  $3^{rd}$  and  $4^{th}$  Round submissions could be up to the 20% cut.

If we submit in this  $2^{nd}$  Round and are cut, then I understand I can attempt to recoup/re-submit in the  $3^{rd}$  Round for the balance.

The Truck Amount is \$190,022.98. (see attached)

5% cut \$9,500.00 10% cut \$19K 15% cut \$28,500 20% cut \$38K

#### 2020 to 2021 Machine Reserve Acct Proposal:

With this proposal, the original \$190K budgeted this year for the truck (or the remaining \$179K at this point) would be moved into the Machine Reserve Acct for the next truck order (Tandem Axle Dump Truck).

I am in the process of getting a quote from Beam Mack for a new truck (2022 Model Year Tandem-Axle Mack Truck). If order in January, could see delivery in late Summer.

I am proposing that this truck be entirely paid for in 2021 budget (likely late Summer/early Fall delivery) from the Machine Reserve Acct.

Upon review with Petra last Friday, I understand this account currently has \$224K and the addition of the unexpended \$179 from the current budget would equate to 403K

Theoretically, I believe more that could be added later this year from various unexpended 2020 DA accounts, but we'll see how we end up (likely from unexpended fuel accounts or other snow accounts).

Additionally, I included another \$50K in my 2021 Budget Proposal to slide into Machine Reserve Account.

Thus, to start off the 2021 Year, we could have \$453K

Regarding selling our next existing 10-wheeler....I don't know if we can plan to sell in our May Auction. Possibly in Monroe County in October. We'll need to discuss that further.

Beam Mack is currently making trucks in 3-months' time. But it's the outfitters that most of the time takes longer to schedule trucks coming in to get outfitted.

At the moment, without any hiccups, I was told from order in January, we could receive the new 2022 Model Year truck by end of summer 2021.

I think this accurately and concisely portrays the individual discussions we had over the past 3-4 days about these ideas.

1. Approve: Book Keeper to Immediately to make Payment to Beam Mack: Councilman Jim Welch made the motion to authorize the book keeper to make immediate payment of \$190,022.98 to Beam Mack Sales Service, Inc, for purchase of a 2021 Mack Granite 6-wheel dump truck.
