The Commission of Highways and Town Clerk reported that they had reduced the highway districts from 48 to 26 and assistants had been appointed in each district. On motion, the Board accepted the report.

Change in Election Districts

Minutes of a special meeting of the Town Board held in the Justice Room of the Village Hall on Monday, June 20th, 1904, called for the purpose of re-districting the town from four election districts to three election districts.

Present: R. N. Backus, Supervisor; M. C. Finley, C. F. Griswold, J. M. Sutphen, and E. H. Clark, Justices of the Peace; and R. H. Barehaus, Town Clerk.

On motion and duly carried, the districts were divided as follows: District No. 1 The lst Election District of the Town of Palmyra shall be bounded as follows: Commencing at the northwest corner of the town line, thence running south along the west town line to the southwest corner of the town line, thence east along the southern boundary of the town to a point opposite the center of Fayette Street, thence north including all citizens living on the west side of Fayette and Market Streets, thence north

including all citizens living on both sides of Gooney and Spyer Road, thence west along the north boundary of the town to place of beginning.

District No. 2 commencing at the south town line at a point opposite the center of Fayette Street, thence north including all citizens living east of the center of Fayette and Market Streets, thence north including all citizens living east of the Spyer and Gooney Roads, thence east along the northern boundary of the town to No. 9 School House House Road, thence south including all citizens living on both sides of No. 9 School House Road, thence south to the center of the canal, thence following the center of the canal to the town line, thence west along the southern boundary of the town to point of beginning.

District No. 3 commencing at a point at the northern boundary of the town running south including all citizens living east of No. 9 School House Road to the center of the canal, thence along the center of the canal to the town line including all citizens living north of the canal from place of beginning, thence north along the eastern boundary of the town, thence west along the town line to place of beginning.

R. N. Backus presided and declared the meeting in order for business.

On motion and duly carried, George G. Throop was appointed Truant Officer for the district schools in place of Carlton J. Foster. The term of office to commence October 1st, 1904, and to serve as Truant Officer until his successor is appointed and duly qualified.

On motion, the compensation of Truant Officer shall remain as heretofore and not to exceed over \$50 per year.

On motion and duly carried, the three voting machines purchased as per resolution on December 22nd, 1903, of the the U. S. Standard Voting Machine Company were accepted and ordered paid as per resolution as follows: Whereas, under the authority of the resolution passed by the Town Board on December 22nd, 1903, the Supervisor and Clerk of the Town of Palmyra in Wayne County and State of New York in its behalf purchased of the United States Standard Voting Machine Company and duly bound the town to pay fifteen hundered dollars (\$1500) for the same.

Now therefore in order to provide for such payment, it is hereby resolved that the Supervisor and Clerk of this town be hereby authorized to borrow for it and in its name fifteen hundred dollars (\$1500) from Pliny T. Sexton, and to execute to him a certificate of indebtedness therefore promising to pay the same as follows; viz., \$500 on February, 1905; \$500 on February 15th, 1906; \$500 on February 15th, 1907; and to pay interest on the same or thereon until the principal be fully paid at the rate of five percent per annum on each February 15th.
