# NOTICE OF PUBLIC HEARING SMALL CITIES GRANT PROGRAM

The Town of Palmyra, New York will hold a public hearing on May 26, 2011, 7:00 PM at the Palmyra Town Hall, 1180 Canandaigua Road, Palmyra, NY, to discuss the Town's intention to submit an application for the Fiscal Year 2011 Community Development Block Grant (CDBG) under the New York State Office of Community Renewal's Small Cities Economic Development Program.

The application will be on behalf of Pulp Packaging, Inc. in the amount of \$200,000. The Grant would allow Pulp Packaging Inc. to purchase and install production equipment at facilities located at 2077 Division Street, Palmyra, NY 14522.

The total project cost is estimated at \$2,200,000. No Town match is required. The project, if funded, will make available 40 full time jobs, 21 jobs of which are for low- and moderate-income persons. No displacement of persons will be proposed. It is anticipated that the application will be submitted by June 23, 2011 and the project activities completed by August 31, 2013.

All citizens, including those in the project area, are encouraged to attend the hearing to consider the potential impacts and benefits of the proposed project for Pulp Packaging, Inc. and to provide suggestions and comments about the proposed application. The Town will provide information at the hearing to comply with the legislative and program requirements that govern the Small Cities Program.

The Town Offices are in compliance with the accessibility standards set forth in the Americans with Disabilities Act. Hearing disabled persons, or those with Limited English Proficiency who wish to attend should call (315) 597-5521 not less than 48 hours before the hearing to make arrangements for an interpreter, if needed. Written public comments will also be accepted.

During the public hearing, discussion included:

Who is Pulp Packaging? Dave Richards explained it is owned by the Freund Box Factory, who wishes to move the Pulp Packaging assets to Division Street.

Is this expansion only for equipment? The preliminary request says it is for equipment and installation.

What about 40 employees? The preliminary request estimates 40 new employees, designated by the Federal Government as low to medium income jobs. Concerns were if current employees would be displaced. The term "displacement," as in "No displacement of persons will be proposed" refers to "displacement, permanent relocation, demolition or conversion of residential units."

Since Division Street properties were approved for storage only, will more tractor-trailers be coming to the facility?

Mike Lambrix said this hearing was necessary so the project could go ahead with the funding request. Ken Miller added, all codes will be kept in the future, but it's too premature now to deal with code enforcement details.

Since the application has not yet been written, there was no information about production, management, etc.

Ken Miller stated there is no detail yet, but the IDA can be contacted if other questions arise.

At 7:11 p.m., Dave Nussbaumer made the motion to close the public hearing.

# TRAILER FOR HIGHWAY DEPT. DISCUSSION

 Purchase of Trailer for Highway Department: Included for sale in the auction was a trailer that the Town purchased in 1995. A new trailer would cost \$5,375, according to a quote Mike Boesel provided this evening. \$7,000 had been budgeted for it. Allowing for the \$1,300 received for the sale of the old trailer, purchasing it at \$5,375 comes in quite a bit under budget.

### 2011 MUNICIPAL AUCTION RESULTS

3. **2011 Auction Results:** This year's auction brought in gross sales of \$3.5 million, up from last year. 128 consigners sold items, with 698 lots being sold. Todd asked about online bidders. Mike said there were 207 registered internet buyers, including some from overseas, with 20 successful purchases. The difficulty with online purchasers, he added, is the delay in picking up their purchased equipment. The sales tax alone for all these auction items is \$28,900.

1. **Assessor's May Office Report:** Assessor Elaine Herman reported that May 24<sup>th</sup> was Grievance Day. Members of the

Board of Assessment Review completed their review of 8 parcels, so no additional day was necessary. She scheduled a meeting with BAR members before Grievance Day to answer questions they might have. She also reports that STAR savings on school tax bills are now being capped at 2% of what 2010-2011 amounts were.

### **RESOLUTION**

### JOIN THE WAYNE COUNTY CABLE COUNCIL

WHEREAS, the Town of Palmyra designates the Wayne County Cable Council as the Administrative Entity for Public, Educational, and Governmental Access as required by New York State Public Service Commission Rules; and

WHEREAS, the Town Board of the Town of Palmyra designates the Wayne County Cable Council to operate Public, Educational, and Governmental Access, and provide liaison to the franchise and others as required for the purpose; and

WHEREAS, the Town Board of the Town of Palmyra designates the Wayne County Cable Council to coordinate administration of the franchise agreement with the other participating towns and villages of Wayne County; and

WHEREAS, the Town Board of the Town of Palmyra has appointed a Representative and an Alternate to the Council, who are authorized to vote on its behalf on matters of franchise administration and administration and operations of Public, Educational, and Governmental Access;

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of Town of Palmyra understands that funding for the administration and operations of Public, Educational, and Governmental Access is not yet determined and that the Council will seek funding sources that may include but are not limited to: School Districts, franchise fees paid to the Towns and Villages, the Wayne County Board of Supervisors, grants, and public fund raising;

AND BE IT FURTHER RESOLVED, that the Town Board of the Town of Palmyra adopt this Resolution.
