Regular meeting of the Town Board was held at the Town Clerk's Office on Friday, March 29, 1918. Present: S. M. Young, Supervisor; H. L. Averill, Clerk; K. F. Young, T. L. Cook, W. E. Spire, and C. W. Williamson, Justices. Meeting was called to order, and minutes were read for information.

Town Superintendent, C. H. Hedden, was present and offered his Determination and Agreement" for road work for 1918; and the following agreement was filled out and three copies filed with County Superintendent, W. G. Sisson of Lyons:

The necessity of appointing a Pound Master and establishing a Dog Pound was discussed at length, and the Supervisor was authorized to investigate the matter and report at a future meeting.

Regular meeting of the Town Board was held at the Town clerkk's Office on Friday, May 10, 1918. Present: S. M. Young, K. F. Young, C. W. Williams (sic), T. L. Cook, and H. L. Averill. Meeting was called to order by Mr. Young, and minutes of last meeting were read for information.

The bill of Dr. W. J. Hennessy for Health Officer from January 1, 1918, to April 1, 1918, and supplies amounting to \$79.00. The Supervisor was instructed to draw a check for the above amount.

A bill was presented by S. E. Braman amounting to \$139.87 for bonds of Town Officers; and on motion the bill was audited and ordered paid. The supervisor was instructed to draw a chack in payment of that amount.

On motion of Judge Williamson, Dr. R. A. Reeves was appointed Health Officer for the Town of Palmyra to fill the unexpired term of the late W. J. Hennessy, and the Clerk was instructed to notify Mr. Reeves of the appointment.

On motion of K. F. Young, a resolutino was passed fixing the salary of the Assessors at \$4.00 a day.

No further business appearing, the meeting adjourned.

Regular meeting of the Palmyra Town Board was held at the Clerk's Office on Friday afternoon, June 14th, 1918. Present: S. M. Young, Supervisor; C. W. Williamson, Kingsley F. Young, W. E. Spire, Thomas L. Cook, Justices; and H. L. Averill, Clerk. The meeting was called to order by Supervisor Young, and minutes of last meeting were read for information.

The matter of establishing a suitable pound for the keeping of untagged dogs and the appointment of a Pound Keeper in accordance with the Dog Law was discussed at length. On motion of Justice Williamson, a resolution was adopted authorizing the Supervisor to make arrangements for a Pound Keeper and suitable pound and for the appointment of an extra Constable for the purpose oof looking after the stray dogs with full power to make necessary arrangements and for the esstablishment of the proper fees for payment of the work.

The question of providing means to handle the increased number of voters that will be registered this fall, owing to thr right of franchise having been given to the women was discussed. It was the sentiment of the Board as well as of the Town Attorney that the voting should be done by machine, thereby saving the expense of re-districting the Town into two or more voting districts. It was decided to purchase two additional voting machiness for use in Districts No. 1 and 2. On motion duly carried, the Supervisor and Justice Williamson were appointed a committee to confer with Attorney George S. Tinklepaugh and to draw up suitable contracts for the purchase of the machines at a sum not to exceed \$600 for each machine.

The matter of a suitable polling place in District No. 3 was taken up, and supervisor Young and Justice Young were named as a committee to take this matter up and report at a future meeting.

No further business appearing, the meeting adjourned. H. L. Averill, Clerk

Regular meeting Town Board was held at the Town Clerk's Office on August, 1918. Present: S. M. Young, Supervisor; H. L. Averill, Clerk; C. W. Williamson, Kingsley Young, W. E. Spire, and T. L. Cook, Justices. The meeting was called to order by Mr. Young, and minutes of last meeting were read for information.

On motion of Justice Charles Williamson, the following polling places were designated for the three Election Districts of Palmyra:

District No. 1 – Justice Room, Village Hall Building

District No. 2 – Garlock Garage, East side of Fayette Street District No. 3 – Ziegler Shop, East Palmyra

The subject of the polling place in District No. 3 was discussed, and the Clerk was instructed to see about procuring a new stove for it and to make any other purchases that were needed to put the building in fit condition for registration and election purposes.

The matter of purchasing the building and land comprising the polling place in District No. 3 was discussed, and Supervisor Young reported that the Town would not be able to purchase real estate without submitted the proposition to the taxpayers of the Town at the annual town meeting.

No further business appearing, the meeting adjourned.

Regular meeting of the Town Board was held at the Town Clerk's Office on Friday afternoon, October 4, 1918. Present: S. M. Young, Supervisor; H. L. Averill, Clerk; T. L. Cook, C. W. Williamson, W. E. Spire, and Kingsley F. Young, Justices. The meeting was called to order by Supervisor Young, and minutes of last meeting were read for information.

Mr. H. Lannon of Newark came before the Board with a claim for damages for injury to his horse and wagon by reason of the steam roller scaring his horse as he was driving on the Port Gibson Road between Port Gibson and Peek's Bridge. Town Superintendent C. H. Hedden was present at the meeting, and he gave the facts in the case as presented to him by his men, who were working with the roller at the time. Mr. Lannon stated that he thought the sum of \$50 would be a reasonable amount, but the matter was finally adjusted by the Town paying Mr. Lannon the sum of \$35. The Supervisor was instructed to draw a check for that amount.

In accordance with the new School Law, the Town Board was authorized to appoint a Truant Office for one year to look after the truants in all the school districts outside of District No. 1; and upon motion of Justice C. W.. Williamson, Kingsley F. Young was appointed to that office at the salary of \$75 per year.

Supervisor Young reported that the two new voting machines had been received and had been examined and were in proper condition for coming election.

No further business appearing, the meeting adjourned.

Mr. C. H. Hedden, Superintendent of Highways, presented his annual estimate of money to be raised for highway purposes, and the report was approved by the Board as follows:
