Town Superintendent C. H. Hedden was present at the meeting, and the matter of making a schedule of "Agreement for Expenditure of Highway Money" as per Highway Law was taken up and discussed at length.

On motion, duly seconded, a resolution was passed authorizing the following expenditures, and the Clerk was instructed to make out reports furnished by the state and forward the same to County Superintendent Sisson.

For the general primary work upon the 80 miles of highway in said town there be expended the sum of \$15 per mile.

For the repair and construction of sluices, culverts, and bridges having a span of less than five feet \$800.

For the permanent extension of highway commencing at New York Central Station and continuing west and north to Durfee Corners and on to the Rodney Parker farm, a distance of two miles \$1500 for grading and gravelling.

It was also decided to reserve in the hands of the supervisor the sum of \$2582.98 as a Contingent Fund to be paid out upon the order of the Town Superintendent in accordance with written directions of the county Superintendent.

Special meeting of the Town Board was held at Clerk's Office on Friday, November 12, 1914. Present: S. M. Young, Supervisor; C. W. Williamson, T. L. Cook, and K. F. Young, Justices; and H. L. Averill, Clerk. Meeting called to order by Supervisor, and minutes of the last meeting were read for information.

The matter of the proposed new highway connecting Division Street near the West Shore Station and Railroad Avenue at a point near Barnhart's Mill was further discussed, and on motion the following resolution was carried:

Resolved that acting on a petition signed by a certain number of taxpayers of the Town of Palmyra, the Town Board, under the powers vested in them under the Highway Laws of the State of New York, hereby authorizes the Town Superintendent to construct and maintain a highway at least three rods wide and in accordance and under the provisions of the Highway Law from the lands owned by the New York Central Railroad, connecting Division Street and the lands owned by Pliny T. Sexton and the Barnhart Estate connecting Railroad Avenue at a point near the Barnhart Mill providing that all the right-of-way necessary for the construction of the road, may be secured and in a manner acceptable to the Town Board.

On motion, duly carried, the following resolution offered by Justice Williamson was carried:

Resolved that the Town Board of Palmyra procure from Attorney G. S. Timklepaugh his interpretation of the Law of the Code of Criminal Procedure, Section 740B regarding constable fees and reading as follows: "For keeping a prisoner after being brought before a Justice in custody one dollar per day." If a prisoner is arrested at nigh and arraigned before the Justice next morning, is the officer entitled to one dollar for custody?

Be it further resolved that Attorney tinklepaugh furnish to the Town board at the earliest possible date his written opinion on above chapter.
