## Town of Palmyra – Minutes for 1913

Meeting of the Palmyra Town Board was held at the Town Clerk's Office on Tuesday, February 18, 1913. Present: C. F. Griswold, Supervisor; T. L. Cook, J. L. Warner, and C. W. Williamson, Justices; and H. L. Averill, Clerk. Meeting was called to order by Mr. Griswold, and minutes of last meeting were read and approved.

Mr. Griswold reported that he had paid to the County Treasurer the sum of \$1453.06, the sum charged to the Town of Palmyra for its share of the county highway construction in this town during 1912.

On motion, duly carried, the Clerk was instructed to draw orders for the payment of the premium on the Town Collector's bond in the sum of \$55.54 and the Supervisor's bond (highway department and school money) amounting to \$27.00.

No further business appearing, the meeting adjourned. H. L. Averill, Clerk

Special meeting of the Town Board was held at the Town Clerk's Office on Tuesday, March 11, 1913. Present: C. F. Griswold, Supervisor; T. L. Cook, J. L. Warner, and C. W. Williamson, Justices; H. L. Averill, Clerk; and C. H. Hedden, Superintendent of Highways. Meeting was called to order by Mr. Griswold, and minutes of last meeting were read for information.

The matter of the agreement and expenditures of highway moneys for 1913 was discussed; and on motion, the following sums were designated: The Clerk was instructed to fill out the proper blanks and forward to the Highway Department.

For general primary work upon the 80 miles of highways in town - \$15 per mile

For the repair and construction of sluices, culverts, bridges, etc. having a span of less than five feet - \$1000

For repairs on road commencing at NY Central Station and leading to Durfee's Corners, a Distance of two (2) miles - \$600 for grading and gravelling

On the road commencing at Jeffery's Corners and leading to Rodney Parker's farm, a distance of 100 rods - \$300 for grading and gravelling

On the road commencing at Newark & Marion Railroad and leading west and north to town line, a distance of 1½ miles \$1000 for grading and gravelling

On the road commencing at --- of Warner Road and leading to town line, Marion, and Palmyra, north and west past Jagger farm, a distance of  $1\frac{1}{2}$  miles - \$400 for grading and gravelling

It was also decided to leave in the hands of the Supervisor the sum of \$1734.16 as a Contingency Fund to be paid in orders drawn by the Town Superintendent.

Regular meeting of the Town Board was held at the Town Clerk's Office on July 11, 1913. Present: C. F. Griswold, Supervisor; T. L. Cook, C. W. Williamson, and J. L. Warner, Justices; C. H. Hedden, Town Superintendent; and H. L. Averill, Clerk. The meeting was called to order by Mr. Griswold, and minutes of the last meeting were read for information.

A resolution was adopted authorizing the Supervisor and Town Superintendent of Highways to make arrangements and let contract for the building of a concrete bridge on the Vienna Road south of the corners near the end of D. G. Briggs' farm.

A motion, duly carried, the Superintendent of Highways was instructed to construct a concrete watering trough at East Palmyra in place of the old wooden trough now in use there.

On motion, duly carried, the action of the Supervisor and Town Superintendent in buying a new road grader was ratified by the Board and their action commended.

No further business appearing, the meeting adjourned. H. L. Averill, Clerk

The regular meeting of the Town Board was held at the Town Clerk's Office on Friday, August 22, 1913. Present: C. f. Griswold, Supervisor; J. L. Warner, C. W. Williamson, and T. L. Cook, Justices; and H. L. Averill, Clerk. The meeting was called to order by Mr. Griswold, and minutes of the last meeting were read and approved.

Supervisor Griswold stated that the contract to erect a new concrete bridge on the Vienna Road had been let to J. A. Darrow & Son for the sum of \$500.

On motion, duly carried, a resolution was passed appointing W. H. Dennis Attendance Officer for the Town of Palmyra for one year from September 1, 1913, at a salary of \$50 a year.

On motion, duly carried, a resolution was passed naming the following polling places for Primary Election, Registration, and General Election:

District No. 1 – Justice Room, Village Hall Building, Main Street

District No. 2 – Garlock Garage and Paint Shop, east side of Fayette Street

District No. 3 - Adam Ziegler's Carriage Shop, East Palmyra

No further business appearing, the meeting adjourned. H. L. Averill, Clerk

The regular meeting of the Town Board was held at the Town Clerk's Office on Friday, October 17, 1913. Present: C. Griswold, Supervisor; J. L. Warner, T. L. Cook, and C. W. Williamson, Justices; and H. L. Averill, Clerk. The meeting was called to order by Mr. Griswold, and minutes of the last meeting were read for information.

Supervisor Griswold reported that the concrete bridge on Vienna Street built by Darrow & Son of Canandaigua was finished, and the same had been approved by the County Superintendent. On motion, duly seconded and carried, Supervisor Griswold was authorized and instructed to draw an order on the Bridge fund for the sum of \$500 in payment of the same.

A communication was received from the T. A. Gillespie Construction Company stating that the temporary siding constructed across the highway from the west shore track near the J. H. Walton residence had been removed, and the company asked that they be relieved from the surety bond. On motion, duly seconded and carried, the Clerk was instructed to notify the Gillespie Company that the highway had been inspected and found to be in good condition and that they were hereby relieved from the necessity of continuing surety bond referred to in original "consent" from this date.

A communication was received from the Central New York Gas & electric company in relation to the discontinuance of the bond given by the company in favor of the town of Palmyra for indemnity against damage caused by said company's gas main on electric wires, which run through township. On motion, duly carried, the Supervisor was instructed to investigate the matter with an attorney and the Clerk was instructed to notify said company of the action.

On motion, duly carried, the Town Superintendent was instructed to construct gravel crosswalks at East Palmyra, the number and size of which to be left with him.

No further business, the minutes were read and approved; and the meeting adjourned.

H. Hedden, Town Superintendent; and H. L. Averill, Clerk. The meeting was called to order by Mr. Griswold, and minutes of last meeting were read for information.

Town Superintendent Hedden presented his estimate for highway purposes for the coming year. Upon motion, duly carried, a resolution was passed approving and accepting the same. The estimate follows:

- 1<sup>st</sup> Item Highway Fund
   For the repair and improvement of town highways, including sluices, culverts, and bridges having a span of less than 5 feet
   \$4000
- 2<sup>nd</sup> Item Bridge Fund
  For the general repair of all bridges having a span of 5 feet or more and not included above
  300
- 3<sup>rd</sup> Item Machinery Fund For the purchase and repair of machinery, tools, and implements 300
- 4<sup>th</sup> Item Miscellaneous Fund
  For removal of obstructions caused by snow, cutting weeds and brush, wire fencing,
  Allowance for shade trees, watering troughs, and other miscellaneous purposes 300

Supervisor Griswold reported that he had consulted an attorney regarding question of Central New York Gas & Electric Company's bond given while their lines and gas mains were being erected through the township, and he stated that the attorney was of the opinion that the Town could not compel said company to continue to bond now that the work of construction had been completed as all damages would now be controlled by the statute. On motion, duly carried, a resolution was passed authorizing the Gas & Electric Company to cancel said bond; and the Clerk was instructed to notify the company of this action.

On motion, duly carried, a resolution was passed authorizing the transfer from the Miscellaneous Fund to the Bridge Fund the sum of \$100.11.

On motion, duly carried, a resolution was passed authorizing the transfer from the Miscellaneous Fund to the Machinery Fund the sum of \$104.02.

No further business appearing, the minutes were read and approved; and the meeting adjourned.

L. Averill, Clerk. Owing to the death of Supervisor Charles F. Griswold, the meeting was called to order by the Clerk; and Justice Thomas L. Cook was chosen Chairman.

After Mr. Cook took the Chair, he announced that the meeting would be held open until after the funeral of the late Charles F. Griswold, which was to be held at 2:30 o'clock. Upon the reassembling of the Board after the funeral, the matter of making an appointment as Supervisor to fill the vacancy caused by the death of Mr. Griswold would be taken up.

The Board re-assembled after the funeral serviced with Mr. Cook in the chair; and upon motion of Justice Charles W. Williamson, duly seconded, the name of Sanford M. Young was placed in nomination for the office of Supervisor.

The appointment was discussed at some length, after which a ballot was taken; and Mr. Young was unanimously elected and appointed to fill the vacancy of Supervisor caused by the death of Charles F. Griswold, to hold office according to law from this date and until his successor is elected or appointed.

The Clerk was instructed to make a copy of the appointment and file in the records of the Town, and to notify Mr. Young at once of his appointment.

Present: James L. Warner, T. L. Cook, C. W. Williamson, and H. H. Averill; and all voted.

No further business appearing, the minutes were read and approved; and the meeting adjourned.

Annual Town Settlement Day of the Town of Palmyra was held at the Town Clerk's Office on Saturday, December 27 at 9:30 o'clock. Present: Sanford M. Young, Supervisor; T. L. Cook, C. W. Williamson, and James L. Warner, Justices; and H. L. Averill, Clerk.

The meeting was called to order by Supervisor Young. Accounts of Overseer of the Poor, A. C. Hopkins, were examined and audited and with his annual report were accepted and ordered placed on file. The report showed expenditures of \$976.37 since January 1, 1912. The receipts, including balance on hand, January 1, 1913, amounting to \$49.98 were \$1059.09 leaving a balance January 1, 1914, of \$82.72.

The records and accounts of the Supervisor in all departments of his office were examined and found to be correct. The various books were signed by the members of the Board. The report showed a balance in the General Fund of \$2418.68, and in the Dog Fund, \$491.98.

On motion, duly carried, the Overseer of the Poor was instructed to pay to Mrs. DeVoist the sum of \$50 for taking care of small pox patient at her home on Main Street.

On motion, duly carried, the First National Bank of Palmyra was designated as the depository for all town funds for the coming year.

On motion, duly carried the following resolution was offered and unanimously adopted: Whereas, on the 27<sup>th</sup> day of November last, in the prime of his manhood and in the midst of labors of great public service, Charles F. Griswold, a member of this Board, was called to his fathers. This sad visitation, coming as it did on a day of national Thanksgiving, changed for his immediate family and friends, a period of joy and festivity into an occasion of deepest grief and

gloom. We, his long-time associates on this Board, while bowing with due humility to an act of inscrutable intelligence, express in these few words our heartfelt sorrows at the loss of one whom we collectively and individually called our friend,

Therefore, be it resolved that in the death of Charles F. Griswold this entire community has lost one whom it will be difficult to replace; one whose taking away has left a vacancy in our midst which will long remain unfilled. In his office he was looked up to and respected, as is evidenced by the many offices of trust and responsibility which he was called upon to fill

Now therefore be it resolved that as an expression of our sympathy and sorrow, the Clerk be instructed to send a copy of these resolutions to the bereaved widow and to have a copy spread upon the minutes of this Board.
